## New NIH Council of Councils Members Named

The National Institutes of Health today announced the appointment of eight individuals to the NIH [Council of Councils](#). The council was established to advise the NIH Director on policies and activities of the Division of Program Coordination, Planning, and Strategic Initiatives (DPCPSI), including making recommendations on research that represents important areas of emerging scientific opportunities, rising public health challenges, or knowledge gaps that deserve special emphasis or would otherwise benefit from strategic planning and coordination.

The council is composed of 27 members nominated by the NIH Institutes and Centers (IC) and offices within the Office of the Director (OD). Council members bring knowledge of their individual IC and OD offices' missions and operations, not as official representatives, but to provide advice beyond the research agenda of any individual IC.

"The breadth and depth of expertise brought by these individuals will enhance the council's ability to achieve its mission by providing diverse perspectives and experience. Collectively the council will inform our approach to selected trans-NIH research initiatives." said DPCPSI Director, and Council of Councils Chair, James M. Anderson, MD, PhD.
